This year's ESFI campaign challenges people across the country to evaluate the electrical safety of their homes, learning more about their electrical systems and devices in the process.

PPL's information centers and environmental preserves at Lake Wallenpaupack and the Susquehanna Riverlands, as well as the Montour Preserve, also feature safety displays and materials for the public.

"A healthy respect for electricity and a basic knowledge of electrical safety practices can help keep your family and home safe from electrical hazards all year long," said ESFI President Brett Brenner.

In the spirit of National Electrical Safety Month, PPL Electric Utilities reminds homeowners and contractors to call Pennsylvania One Call at 811 or 1-800-242-1776 at least three business days before any digging that could be around underground utility facilities. That allows utilities to mark the presence of pipes and lines. Remember that underground electric lines serving housing developments carry the same voltages as overhead lines. Hitting them can cause serious injury or death.

Caution is urged when working around overhead lines, too – whether trimming a tree, working on ladders or scaffolding, or using any equipment. Look up, be aware and make sure you stay at least 10 feet away from power lines. The safe distances increase as voltages increase. Call PPL Electric Utilities at 1-800-342-5775 if you are unsure of a line's voltage. The federal Occupational Safety and Health Administration also has safety clearance requirements.
